TREASURER'S REPORT:

Treasurer, Judy Graham, budget report, and treasurer's report. In the month of December, we took in \$5,590.00 in income and spent \$1,185.00. Ending balance of \$10,083.24. Holiday luncheon report: we made \$3,867.74. At this moment our fund balance is basically \$6,000.00. Debe Lightle still has an outstanding District 2 Conference expense, there is a \$31.00 bill for a Programs of Service ad that was ran in the Examiner, and in addition to a mandatory Federation Convention bill that should arrive shortly for about \$800.00.

COMMITTEE REPORTS:

Programs of Service Projects – Lissa Webbon provided the Programs of Service, in the absence of Chair Charley Tracy. Lissa presented the projects and ballots for a membership vote. She gave a brief explanation of what Programs of Service is for our new members. There is an explanation on page 26 of our Member Books. After extending our application deadline, we ended up with nine (9) applications. Only four (4) of these met the criteria: Warner Canyon Ski Hill Rope Tow, Outpatient Nursing & Infusion Services, Patient and Family Support, Books & Art Prints, Dove Advocacy Center, and Business Improvements, Downtown Café & Bakery. Lissa discussed why the five (5) applications did not meet the criteria. Voting took place and was tallied by Barb

Simpson and Sally Fitzgerald, resulting in #4 Dove Advocacy – 50pts, #3 Hospital – 60pts, #2 Downtown Café & Bakery – 62 pts, and #1 Warner Canyon Ski Hill – 65pts.
